Commander Painter appointed Dan Hempsall as Judge Advocate, Barry Litsky and Sheri Rodriguez as Service Officers, and Sheri Rodriguez as Adjutant.

Officer's Reports

The Commander reported about his experience at the Convention and how Post 372 can get more involved by hosting more Legion Programs such Law & Order and Teacher of the Year Awards. He also provided a summary of the Executive Board Meeting held on July 6, 2017.

The First Vice Commander provided an update on Post 372's membership and noted that we ended the year at 160.24% which put is in first place in the 5^{th} District. Former Commander Myra Jowers was named District Commander of the Year for her hard work and dedication to Veterans and the American Legion.

The goal for this year is 117 but we need 118 to be eligible for the Post Excellence Award. He noted that he is working with the Project Stay Active list and has had one response. The list is hard to work because 163 do not have an email address listed and 116 have no phone number listed.

The Judge Advocate thanked everyone who participated in the Flag Day activities.

The Adjutant reported that she has processed all membership renewals she has received and estimates Post 372's membership percentage to be approximately 44%.

The Sergeant-at-Arms had no report.

The Chaplain had no report.

Service Officer Litsky reported that he will resume his office hours on Tuesdays from 4:30 – 6:00pm at the Mandarin/St. Johns Elks Lodge.

Service Officer Rodriguez stated that she is posting VA information on Facebook and will begin office hours once school is back in session.

The Commander thanked the Officers for their work on the Post's transition during the long process.

Unfinished Business

The First Vice Commander reported that Sunbiz has been successfully updated and that all bank accounts have been transferred to the new Post Officers. Finance Officer Comeaux is the primary on the accounts. The First Vice Commander and Adjutant are secondary on the accounts. The 990 was filed by former Adjutant, Carl Jowers and is due again approximately 5 ½ months after the end of the Legion's fiscal year. The First Vice filed the 8822B which reports the change of responsible party to the IRS.

The Judge Advocate reported that he is working on updating the By-Laws with the addition of the Auxiliary and an annual audit requirement. It was asked why the Auxiliary needed to be added if they are their own entity. The Adjutant stated that she will research.

The Commander noted that the Auxiliary needs to use our bank account to receive money and pay bills until their Charter is approved and they can set up their own accounts.

Motion to create a subaccount for the Auxiliary in the Post's finances was made and seconded. The motion passed unanimously.

The Adjutant showed a sample of a recruiting t-shirt for events and noted that she was going to get pricing for orders.

New Business

The First Vice Commander reported that there is interest in forming an SAL Squadron at Post 372. There are currently three to four interested.

The Commander suggested that a recruiting incentive program be created so that members who recruit members can win gift cards in a drawing. The Membership discussed an
